Eagle Ranch Academy was one of the many places my parents sent me to in desperate need to find me help. By 17 I was doing drugs and binge drinking daily, running around with gangs, robbing, stealing, fighting, and running away. I was always in denial that I had a problem until I was sent to ERA, but like most teens when I was first transferred to ERA I wanted to so badly get out that I would do and say anything It took to get my parents to remove me from the program. This is what I believe prompted my mom, Jamie Kinsman, to create the horrid websites about ERA. I believe she created the websites in attempt to get my dad to release me from ERA as he had more custody. My mom had been doing a lot of research and found out that there are programs out there that abuse children so when she came to visit me and would ask me questions I would always bad mouth ERA in a desperate attempt to go home but instead it back fired on me and I lost all communication with my mom for the remainder of my stay at ERA. This was so I could focus on myself and my program. During my stay at ERA there was no abuse going on at all. Day to day activities normally consisted of school, PE, breakfast, lunch & dinner, cleaning up, rec-room (free time), siesta (nap time- free time), group, & activities with our pods. What I learned in ERA is that if you try and cheat the program you are only cheating yourself. ERA teaches you new tools and how to use them in everyday life but it is up to you weather you use them or not. ERA also taught me there is always something to be learned and that ERA is just another learning experience.

I have a lot to be grateful for and I thank ERA & all the staff there for helping me through my struggles and showing me tools needed to better manage my life. Today, instead of drugs, binge drinking, running around with gangs, robbing, stealing, fighting, and running away, I now enjoy working full time(and have been able to keep the same job for over a year), living on my own, and living life to the fullest! I have been given so many great opportunities since being released from ERA and I intend to take full advantage of them. I can't describe the feeling I get when I see how proud my family is of me and the choices I have made, but the best feeling is being proud of myself, I never thought I would be one to write a letter about how ERA had such a great impact on my life but the program truly saved me from myself. I would recommend ERA to anyone in need of help, the program saved my life, and it will save your teens too.
